The records also show that one H. C. Hale, private, Company A, 20th (Russell's) Tennessee Cavalry (subsequently a part of the 19th and 20th Consolidated Tennessee Cavalry), C.S. A., enlisted July 10, 1863. As a member of Company E of the last-named organization he was surrendered May 4, 1865, at Citronelle, Alabama, and was paroled May 11, 1865, at Gainesville, Alabama. His residence is shown to have been in Gibson County, Tennessee.


